
AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF UNIVERSITIES PRIVATE IN THE STATE OF TELANGANA WITH **OBJECTS** TO PROVIDE QUALITATIVE, RESEARCH ORIENTED, **INDUSTRY** RELEVANT AND WORLD CLASS HIGHER EDUCATION AND TO REGULATE THEIR FUNCTIONS AND FOR THE MATTERS CONNECTED THEREWITH OR INCIDENTAL THERETO.

Be it enacted by the Legislature of the State of Telangana in the Sixty-ninth year of the Republic of India, as follows:-

CHAPTER - I **PRELIMINARY**

- 1. (1) This Act may be called the Telangana State Private Short title, extent Universities (Establishment and Regulation) Act, 2018. and
 - commencement.
 - (2) It extends to the whole of the State of Telangana.
- (3) It shall come into force on such date as the State Government may, by notification in the official gazette, appoint.

Definitions.

2. In this Act, unless the context otherwise requires,-

Central Act No.52 of 1987.

a) "AICTE" means the All India Council for Technical Education established under section 3 of the All India Council for Technical Education Act, 1987;

Central Act No.21 of 1860.

- b) "AIU" means, the Association of Indian Universities registered under the Societies Registration Act, 1860;
- c) "BCI" means the Bar Council of India established under the Advocates Act, 1961;
- d) "CSIR" means the Council of Scientific and Industrial Research, New Delhi, a funding agency of the Central Government;
- e) "DST" means the Department of Science and Technology of the Central Government;
- f) "Eminent Persons" means persons of impeccable integrity having outstanding knowledge and expertise in academics, scientific research and all other related subjects;
- g) "Expert Committee" means a Committee of eminent persons notified by the Government to promote, facilitate and assist in the establishment of new Private Universities in Telangana constituted under this Act;
- h) "Fee" means collection of amount made by the University from the students for different purposes under different heads and which is non-refundable:
 - i) "Government" means the Government of Telangana;
- j) "Higher Education" means study of a curriculum or course for the pursuit of knowledge beyond 10+2 level;



- k) "Hostel" means a place of residence for the students of the University:
- I) "ICAR" means the Indian Council of Agricultural Research, a Society registered under the Societies Registration Act, 1860;

m) "MCI" means the Medical Council of India Central Act No.102 of constituted under the Medical Council Act, 1956;

1956.

- "NAAC" means the National Assessment and Accreditation Council, an autonomous institution of the UGC:
- o) "NCTE" means the National Council for Teacher Education established under the National Council for Teacher Education Act, 1993;

Central Act No.73 of

- p) "Notification" means the Notification published in the Telangana Gazette and the word 'notified' shall be construed accordingly;
- q) "PCI" means the Pharmacy Council of India Central Act No.8 of constituted under section 4 of the Pharmacy Act, 1948;
- r) "Prescribed" means prescribed by the rules made under this Act;
- s) "Regulatory Body" means a body established by the Central Government, for laying down the norms and conditions for ensuring academic standards of Higher Education, such as UGC, AICTE, NCTE, DBT, DST, BCI, MCI, PCI, NAAC, ICAR, DEC and CSIR;
- t) "Regulations" means the Regulations made by any authority of the University under section 31;

- u) "Rules" means the Rules made under section 46;
- v) "Schedule" means the Schedule appended to this Act;
- w) "Sponsoring Body" in relation to a University established under this Act means:-

Central Act No.21 of 1860.

(i) a society "not for profit" registered under the Societies Registration Act, 1860; or the Telangana State Societies Registration Act, 2001; or

Central Act No.2 of 1882.

(ii) a public trust "not for profit" registered under the Indian Trusts Act, 1882; or

Central Act No.13 of 2013.

- (iii) a company registered under section 8 of the Companies Act, 2013;
- x) "Statutes" and "Ordinances" mean the Statutes and the Ordinances of the University made under this Act;
- y) "Specified" means specified by Ordinances Statutes and Regulations under this Act;
- za) "Student" means a student of the University and includes any person enrolled in the University for pursuing any course of study for a degree, diploma or other academic distinction duly instituted by the University including a research degree;
- zb) "Teacher" means a Professor, Associate Professor, Assistant Professor or any other person required to impart education or to guide research or to render guidance in any other form to the students for pursuing a course of study of the University;



zc) "UGC" means the University Grants Commission established under section 4 of the University Grants Commission Act, 1956;

Central Act No.3 of 1956.

zd) "University" means a Private University established under section 3 of this Act.

CHAPTER - II ESTABLISHMENT OF UNIVERSITY

3. (1) The Government may permit the establishment of a University by inclusion of the name and location of the University, the name and address of the Sponsoring Body and details of its registration mentioned in the Schedule.

Establishment and incorporation of the University.

- (2) The location of the University shall be within the State of Telangana and shall be notified by the Government.
- (3) The University shall be unitary in nature and shall not have power or provision to affiliate and recognize any college or institution to it.
- (4) The University shall normally be permitted to have one campus to start with:

Provided that the Government may, under exceptional circumstances such as starting of few specialised courses close to the industrial clusters, if it deems fit, permit two additional campuses/centres subject to adherence to quality levels and satisfactory accreditation standards as may be specified:

Provided further that the Government may permit to open additional campuses/centres beyond the initial three campuses, if any, anywhere within the State of Telangana subject to satisfactory running for a period of five years and



fulfilment of such infrastructure and other requirements as may be specified by Government.

- (5) The University will be free to and is encouraged to use technology extensively as part of its curriculum in line with modern pedagogic concepts.
- (6) The Governing Body, the Board of Management, the Academic Council, the Chancellor, the Vice-Chancellor, the Registrar and the Chief Finance and Accounts Officer and such other officers or members or authorities, so long as they continue to hold such office or membership of the respective University mentioned in the Schedule, hereby constitute a body corporate by the name of the said University specified in the Schedule.
- (7) The Private University shall implement the relevant UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 and any other rules and Regulations laid down by the UGC and other Regulatory Bodies from time to time in this regard.
- (8) Each such University shall be a body corporate by the name specified in the Schedule and shall have perpetual succession and common seal with power, subject to the provisions of this Act, to acquire and hold property, to contract and shall, by the said name, sue or be sued.
- (9) The Universities shall not claim as a matter of right any grant-in-aid or other financial assistance from the State Government or the Central Government:

Provided that this shall not prohibit any Private University from applying for research projects or any other prescribed academic projects which may or may not entail financial grants from the Central or State Government or any other institutions.



4. The Goals and Objects of the University shall be to create, organize, preserve and disseminate knowledge in the fields of science and technology, humanities, social sciences, education, management, commerce, law, pharmacy, healthcare and any other field for the advancement of mankind in particular and other objects of the Universities shall be as follows, namely:-

Goals and Objects of the University.

- (a) to provide for instruction, teaching, and training in the University in the field of higher education and make provisions for research, innovation, advancement and dissemination of knowledge;
- (b) to establish and maintain a campus with international standards of education;
- (c) to develop infrastructure for research in higher education, professional education, teaching, training, extension and outreach;
 - (d) to create higher levels of intellectual abilities;
- (e) to establish State of the art facilities for education and training;
 - (f) to carry out teaching and research;
- (g) to create and maintain centres of excellence for research and development and for sharing knowledge and its application;
- (h) to provide avenues for innovation, set up incubation centres and to develop entrepreneurship skills;
- (i) to provide consultancy to the industry and public organisations;



- (j) to encourage and use the latest technology for education, research and training;
- (k) to confer degrees, diplomas and other academic distinctions on the basis of an approved method of evaluation as established by the Academic Council of the University, keeping in view the guidelines of the University Grants Commission and other connected Regulatory Bodies;
- (I) to develop educational programmes for diplomas, degrees and post-graduate courses, doctorate degrees and post-doctoral programmes and to maintain high standards of education;
- (m) to collaborate with national and global institutions, to offer programmes and to create capabilities for upgrading programmes to the global standards subject to the guidelines of the UGC and other connected Regulatory Bodies;
- (n) to ensure that the standards of the degrees, diplomas and other academic distinctions are not lower than those laid down by the Regulatory Bodies;
- (o) to establish close linkage with the industry, business, educational institutions and other sections of the society to make teaching, research, training, documentation, publication, use of various media and outreach activities at the University relevant to the needs of the University, time and society, at national and international level;
- (p) to pursue any other objectives as may be approved by the Government:

Provided that notwithstanding anything contained in this Act and save as provided in any Central Act, the University



shall be eligible to undertake the functions of dissemination of knowledge only in the fields for which the Government has issued Letter of Intent or in the fields subsequently approved by the Government.

5. The University shall exercise the following powers and perform the following functions, namely:-

Powers and functions of the University.

- (i) to administer and manage the University, for research, teaching, learning, training, extension and e-learning in the approved fields at its campus within the State of Telangana;
- (ii) to provide for research in higher education, professional education, teaching, learning, training, extension and e-learning in the approved fields;
- (iii) to conduct innovative experiments in educational technologies, teaching and learning methods and to collaborate with national and international institutions to offer joint programmes recognised by the Regulatory Bodies, to constantly improve the delivery of education and to achieve international standards of education;
- (iv) conduct programmes and courses of study that are in the opinion of the University, necessary for the furtherance of its objects in the approved fields;
- (v) to hold examinations and confer degrees, diplomas and other academic distinctions or titles on persons subject to such condition as the University may determine and to withdraw or cancel any such degrees, diplomas and other academic distinctions or titles in the manner prescribed by the Ordinances and Regulations;
- (vi) to confer honorary degrees or other distinctions in the manner prescribed by the Statutes;



- (vii) to provide for publications and reproduction of research, educational material and other works and to organize exhibitions conferences, workshops and seminars;
 - (viii) to establish knowledge resource centre;
- (ix) to sponsor and undertake research and educational programmes in the approved fields of science and technology, humanities, social sciences, education, management, commerce, law, pharmacy, healthcare and any other allied areas;
- (x) to obtain registration in respect of research in the nature of patents, design rights and such or similar intellectual property rights with the competent authorities;
- (xi) to maintain linkages and collaborate with educational or other institutions in any part of the world having objects wholly or partially similar to those of the University, through exchange of students, researchers, faculty and staff and generally in such manner as may be conducive to their common objects;
- (xii) to render services of research, training, consultancy and such other service, as required for the purposes of the University;
- (xiii) to develop and maintain relationships with faculty, researchers, administrators and domain experts in science and technology, humanities, social sciences, education, management, law, commerce, pharmacy, healthcare and allied area for achieving the objects of the University;
- (xiv) to regulate the expenditure and to manage the finances and to maintain the accounts of the University;





- (xv) to receive funds, movable and immovable properties, equipments, software and other resources from business, industry, other sections of society, national and international organization(s) by transfer or as gifts, donations, benefactions or bequests, as valid under the relevant Laws, for the purposes and objects of the University;
- (xvi) to establish, maintain, manage the hostels for students, establish quarters for the residence of faculty and staff;
- (xvii) to construct, manage and maintain complexes, auditorium, buildings, stadium for the advancement of sports, cultural, co-curricular and extra-curricular activities;
- (xviii) to supervise and control the residence and regulate the discipline of students, faculty and staff of the University and to make arrangements for promoting their health, general welfare, social and cultural activities;
- (xix) to fix, demand and receive or recover fees and such other charges as may be prescribed by the Statutes;
- (xx) to institute and award fellowships, scholarships, prizes, medals and other awards;
- (xxi) to purchase or to take on lease or accept as gifts, bequests, legacies or otherwise any land or building or works which may be necessary or convenient for the purpose of the University and on such terms and conditions as it may think fit and proper and to construct or alter and maintain any such building or works;
- (xxii) to sell, exchange, lease or otherwise dispose of all or any portion of the properties of the University, movable or immovable, on such terms as it may think fit and consistent



with the interest, activities and objects of the University, with the prior permission of the Government;

(xxiii) to draw and accept, to make and endorse, to discount and negotiate promissory notes, bills of exchange, cheques and other negotiable instruments;

(xxiv) to raise and borrow money on bond, mortgages, promissory notes or other obligations or securities founded or based upon all or any of the properties and assets of the University or without any securities and upon such terms and conditions as it may think fit and to pay out of the funds of the University, all expenses incidental to the raising of money, and to repay and redeem any money borrowed, with the prior permission of the Government;

(xxv) to invest the funds of the University in or upon such securities and transpose any investment from time to time in such manner as it may deem fit in the interest of the University with the prior permission of the Government;

(xxvi) to execute conveyances regarding transfers, mortgages, leases, licenses, agreements, and other conveyances in respect of property, movable or immovable including Government securities belonging to the University or to be acquired for the purpose of the University with the prior permission of the Government;

(xxvii) to admit students for the courses offered by the University in the manner prescribed by the Ordinances;

(xxviii) to create academic, technical, administrative, ministerial and other posts prescribing qualifications by the Statutes and to make appointments thereto;

(xxix) to regulate and enforce discipline among the students, employees of the University and to provide for



such disciplinary measures as may be prescribed by the Regulations;

(xxx) to institute professorships, associate professorships, assistant professorships and any other teaching, academic or research posts and to prescribe by the Statutes, the qualifications for the persons to be appointed on such posts;

(xxxi) to appoint qualified persons as professors, associate professors, assistant professors or as teachers and researchers or other officers of the University in such manner as may be prescribed by the Statutes;

(xxxii) to collaborate with other National and International Universities and acquire membership of bodies, authorities, or associations, which may have been formed with like or similar objects for the advancement of learning, science or research, or for the dissemination of knowledge or for the physical and moral welfare of the students, in such manner and for such purpose as the University may determine by Statutes;

(xxxiii) to delegate all or any of its powers except the power to make Regulations to any officer or authority of the University as per the Statutes and Ordinances of the University;

(xxxiv) to do all such acts and things as the University may consider necessary, conducive or incidental to the attainment or enlargement of all or any of the objects of the University.

6. Any Sponsoring Body desirous to have a Private University established by a law of the State Legislature, shall make an application to the Government, containing among other things an outline of the purpose and vision of the

Application for establishment of the University.



proposed Private University and the proposal and the Project Report in such manner containing such particulars along with such fee as may be prescribed, from time to time.

Project Report.

- 7. In addition to the particulars as may be prescribed under section 6, the Project Report shall contain the following, namely:-
- (a) justification regarding the necessity of establishment of the proposed University;
- (b) the details of the Sponsoring body along with the copies of its registration certificate under the Societies Registration Act, 1860, or Telangana State Societies Registration Act, 2001 or Public Trust Act or the Companies Act, 2013, constitution and bye-laws;
- (c) the information regarding financial resources of the Sponsoring Body along with audited financial statements for the last five years;
- (d) the track record, experience and domain expertise in the disciplines proposed at the command of the Sponsoring Body;
- (e) the name, location and headquarters of the proposed University;
 - (f) the objectives of the University;
- (g) plan for pre-commencement activities, including in academic & non-academic areas;
- (h) availability of academic facilities including teaching and non-teaching staff, if any at the disposal of the Sponsoring Body;



- (i) the details of plans for campus development such as construction of buildings, development of structural amenities and infrastructure facilities and procurement of equipment, etc., to be undertaken before the University starts functioning and further required construction area as prescribed from time to time by the Government;
- (j) the outlays of capital expenditure and its sources of finance;
- (k) the nature and type of programmes and courses of study, research and innovation proposed to be undertaken by the University and their relevance to the development goals and employment needs of the State with course-wise enrolment targets;
 - (I) the nature of facilities proposed to be started;
- (m) the estimated recurring expenditure course-wise or activity-wise, sources of finance and estimated expenditure per student;
- (n) the scheme of mobilizing resources and the cost of capital thereto and the manner of repayment to such sources;
- (o) projected detailed financial statements and key operating ratios with a detailed break-up of sources of revenues generated internally through the recovery of fee from the students, professional income such as through consultancy services, ancillary income from the student services such as student housing, other activities relating to the objects of the University and other anticipated incomes;
- (p) the proposed fee structure with reference to the details of expenditure on unit cost and the extent of concessions or rebates in fee or free-ships and scholarships



to the poor students from economically poor or socially backward families, including Scheduled Castes. Scheduled Tribes, other Backward Classes and differently abled students;

- (q) the system proposed to be followed for selecting students for admission to the courses of study at the University;
- (r) the system proposed for appointment of faculty and other employees in the University;
- (s) the nature of specialized teaching, training or research activities to be undertaken by the University so as to fulfil its objects and the University proposes to undertake related to local needs;
- (t) the relevant details must also be provided if the University proposes to start some programmes for the benefit of farmers, women and industries;
- (u) the details of play grounds and other facilities available or proposed to be created for games and sports and extra-curricular activities like National Cadet Corps, National Service Scheme, Scouts and Guides;
- (v) proposed approach and initial plans for academic and research excellence, including accreditations to be sought and academic auditing;
- (w) commitment to follow the norms of the Regulatory Bodies;
- (x) such other details as the Sponsoring Body may like to give;



- (y) such other details as may be prescribed or notified from time to time.
- 8. (1) The Government shall constitute an Expert Committee consisting of such members as may be specified by it to examine the application received under sections 6 and 7 for setting up of a Private University.

Expert Committee.

- (2) The Expert Committee shall consider the proposal and the Project Report based on the information given under sections 6 and 7 and recommend or otherwise whether the proposal to set up a Private University is acceptable and whether the Sponsoring Body is competent to set up and manage the University.
- (3) The Expert Committee shall consider each proposal and Project Report with reference to the following factors:-
- (a) financial soundness and assets of the Sponsoring Body and its ability to set up the infrastructure of the proposed University;
- (b) background of the Sponsoring Body such as experience in the field of education, its credibility and general reputation;
- (c) potential of the programme and courses to be offered which are not only of conventional nature but also in tune with the contemporary requirements of emerging branches of learning and relevant to various development sectors and to the society in general;
- (d) appropriateness of the objectives of the proposed University against the overall goals and objectives of the State; and



- (e) any other factor that the Expert Committee may deem appropriate.
- (4) The Expert Committee, while considering the proposal and the Project Report, may call for such other information from the Sponsoring Body as it thinks proper for the purpose.
- (5) The Expert Committee shall submit its recommendation to the Government as far as possible within a period of 60 days from the date of receipt of the proposal and Project Report from the Government.
- (6) The Expert Committee may recommend to the Government appropriate additional measures for Private Universities, from time to time.

Letter of Intent.

9. (1) After receipt of the recommendations of the Expert Committee under section 8, the Government shall take a decision on accepting, rejecting, or seeking modifications in the proposal and Project Report, as far as possible within a period of 30 days:

Provided that the Government may consider the additional measures as recommended by the Expert Committee under sub-section (6) of section 8.

- (2) The Government shall inform the Sponsoring Body about its decision through a Letter of Intent, or a Letter of Regret, or a Letter seeking additional clarifications.
- (3) The Government, while issuing the Letter of Intent, shall require the Sponsoring Body to fulfill such terms and conditions as recommended by the Expert Committee. If the letter from the Government seeks additional clarifications, the Sponsoring Body may provide the same and that shall be considered as a resubmission of the Application.



(4) The Sponsoring Body shall fulfill the terms and conditions and report compliance to the Government within a period as prescribed from the date of the issue of the Letter of Intent:

Provided that Government may further extend the period for a maximum period of one year, if it is satisfied that the Sponsoring Body has taken substantial steps towards setting up of the University.

- (5) On receipt of the compliance report, the Government shall, within a period of one month, request the Expert Committee, constituted under section 8 to verify the compliance report within a period of 30 days.
- 10. If the Government is satisfied that the Sponsoring Body has complied with the conditions of Letter of Intent and on the specific recommendations of the Expert Committee, it shall include the name of the University in the Schedule with details of its location by way of amendment of the Schedule.

Establishment and incorporation of the University by Legislation.

11. Subject to the provision of sub-section (4) of section 3, the University may, as and when it deems fit and proper, establish and manage additional campuses/centres for research, education, training, extension and outreach within the State of Telangana.

Management of certain institutions.

12. (1) No person shall be excluded from any office of the University or from membership of any of its authorities or from admission to any degree, diploma or other academic distinction or course of study on the ground of sex, race, creed, class, caste, place of birth, religious belief or political or other opinion.

University open to all irrespective of sex, religion, class, creed or opinion.

(2) It shall not be lawful for the University to impose on any person any test whatsoever relating to sex, race, creed, caste, class, place of birth, religious belief or political or



other opinion in order to entitle him to be admitted as a student or to hold any office or post in the University or to qualify for any degree, diploma or other academic distinction or to enjoy or exercise any privileges of the University or any benefaction thereof.

CHAPTER - III OFFICERS OF UNIVERSITY

Officers of the University.

- 13. The following shall be the officers of the University, namely:-
 - (a) The Chancellor;
 - (b) The Vice-Chancellor;
 - (c) The Registrar;
 - (d) The Chief Finance and Accounts Officer; and
- (e) such other officers as may be declared by the Statutes to be the officers of the University.

Chancellor.

14. (1) The Chancellor shall be appointed by the Sponsoring Body for a period of three years selected by a Search Committee, by following such procedure and on such terms and conditions as may be prescribed.

Explanation:- For the purpose of this Chapter, Search Committee shall mean a Search Committee constituted by the Sponsoring Body and consisting of a minimum of three members nominated from the Board of Management.

- (2) The Chancellor shall be the head of the University.
- (3) The Chancellor shall preside over the meetings of the Governing Body and shall preside over the convocation



of the University for conferring degrees, diplomas or other academic distinctions and in his absence by any other member of the Governing Body nominated by it.

- (4) The Chancellor shall have the following powers, namely:-
 - (a) to call for any information or record;
- (b) to remove the Vice-Chancellor in accordance with the provisions of sub-section (6) of section 15;
- (c) such other powers as may be prescribed by the Statutes.
- (5) The term of the office of the Chancellor shall be as may be specified in the Statute.
- 15. (1) The Vice-Chancellor shall be appointed by the Vice-Chancellor. Chancellor from a panel of three persons recommended by the Search Committee and subject to the provisions of subsection (6), hold office for a term of three years or upto the age of 70 years, whichever is earlier:

Provided that, after expiry of the term of three years, a person shall be eligible for re-appointment for another term of three years, subject to the upper age limit of 70 years:

Provided further that the Vice-Chancellor shall continue to hold office even after expiry of his term till a new Vice-Chancellor takes charge of the office, however in any case this period shall not exceed one year:

Provided also that the Chancellor may appoint the first Vice-Chancellor for a period of one year or until a regular Vice-Chancellor is appointed under this section whichever is earlier.



- (2) The Vice-Chancellor shall be the principal executive and academic officer of the University and shall exercise general superintendence and control over the affairs of the University and shall execute the decisions of various authorities of the University.
- (3) Where, in the opinion of the Vice-Chancellor, it is necessary to take immediate action on any matter for which powers are conferred on any other authority by or under this Act, he may take such action as he deems necessary and shall at the earliest opportunity thereafter report his action to such officer or authority as would have in the ordinary course dealt with the matter:

Provided that if in the opinion of the concerned officer or authority such action should not have been taken by the Vice-Chancellor then such case shall be referred to the Chancellor whose decision thereon shall be final:

Provided further that where any such action taken by the Vice-Chancellor affects any person in the service of the University such person shall be entitled to prefer, within three months from the date on which such action is communicated to him; an appeal to the Governing Body and it may confirm or modify or reverse the action taken by the Vice-Chancellor.

(4) Where, in the opinion of the Vice-Chancellor, decision of any authority of the University is not within the powers conferred by this Act or the Statutes, the Ordinances, the Regulations or the rules or is likely to be prejudicial to the interest of the University, he shall request the authority concerned to revise its decision within fifteen days from the date of its decision and in case the authority refuses to revise such decision wholly or partly or fails to take any decision within fifteen days, then such matter shall



be referred to the Chancellor and his decision thereon shall be final.

- (5) The Vice-Chancellor shall exercise such powers and perform such functions as may be specified by the Statutes or the Ordinances.
- (6) If, at any time upon representation made or otherwise and after making such inquiry as may be deemed necessary, the situation so warrants and if the continuance of the Vice-Chancellor is not in the interests of the University, the Chancellor may, by an order in writing stating the reasons therein, ask the Vice-Chancellor to relinquish his office from such date as may be specified in the order:

Provided that before taking action under this subsection the Vice-Chancellor shall be given an opportunity of being heard in person.

- 16. (1) The appointment of the Registrar shall be made by Registrar. the Chancellor in such manner as may be specified by the Statutes.
- (2) All contracts shall be signed and all documents and records shall be authenticated by the Registrar on behalf of the University.
- (3) The Registrar shall be the Member-Secretary of the Governing Body, the Board of Management and Academic Council but he shall not have a right to vote.
- (4) The Registrar shall exercise such powers and perform such duties as may be specified in the Statutes or the Ordinances.



Chief Finance and Accounts Officer.

- 17. (1) The appointment of the Chief Finance and Accounts Officer shall be made by the Chancellor in such manner as may be specified by the Statutes.
- (2) The Chief Finance and Accounts Officer shall exercise such powers and perform such duties as may be specified in the Statutes or the Ordinances.

Other Officers.

- 18. (1) The University may appoint such other Officers as may be necessary for its functioning.
- (2) The manner of appointment of other officers of the University and their powers and functions shall be such as may be specified in the Statutes or the Ordinances.

CHAPTER - IV AUTHORITIES OF UNIVERSITY

Authorities of the University.

- 19. The following shall be the authorities of the University, namely:-
 - (a) The Governing Body;
 - (b) The Board of Management;
 - (c) The Academic Council; and
- (d) such other authorities as may be declared by the Statutes to be the authorities of the University.

Constitution, Tenure, Quorum, Powers etc., of the Governing Body.

- 20. (1) The Governing Body of the University shall consist of at least six members including the following members, namely:-
 - (a) the Chancellor;
 - (b) the Vice-Chancellor;

(c) members to be nominated by the Sponsoring Body who shall be eminent people of standing in the fields as may be specified:

Provided that it shall be the duty of the Sponsoring Body to maintain the gender parity, in nominating women members not less than one half of the total members in the composition of the Governing Body;

- (d) officer not below the rank of Secretary to the Government of Telangana, to be nominated by the Government:
- (2) (a) Save as otherwise provided in this section the term of nominated members of the Governing Body shall be minimum of three and maximum of five years from the date of nomination:

Provided that each nominated member is eligible to hold the position for additional term of not more than ten years;

- (b) An ex-officio member shall continue so long as he/ she holds the office by virtue of which he/ she is such a member;
- (c) Nearly one third of the nominated members, except the ex-officio member shall retire by rotation each year. In the first two instances, the Board of Management may decide the procedure to identify the members who will retire;
- (d) A member may resign from his office by writing under his hand, addressed to the Chairperson, but he shall continue in office until his resignation has been accepted by the Chairperson.



- (3) The Governing Body shall be the overarching supervisory and statutory authority of the University. All the movable and immovable property of the University shall vest in the Governing Body.
- (4) The Governing Body shall have the following powers namely:-
- (a) to provide general superintendence and directions and to control functioning of the University by using all such powers as are provided by this Act or the Statutes, Ordinances, Regulations or rules made thereunder;
- (b) to review the decisions of other authorities of the University in case they are not in conformity with the provisions of this Act or the Statutes, Ordinances, Regulations or rules made thereunder;
- (c) to approve the budget and annual report of the University;
- (d) to lay down the extensive policies to be followed by the University;
- (e) to recommend to the Sponsoring Body about the voluntary liquidation of the University;
- (f) such other powers as may be prescribed by the Statutes:
- (g) to vest to the Board of Management or any other entity or official of the University such of its powers as it deems appropriate, along with appropriate governance mechanism.



- (5) The Governing Body shall meet at least four times in a financial year with one meeting in each quarter.
- (6) A minimum of one-half of the members shall form the quorum for a meeting of the Governing Body.
- 21. (1) The Board of Management shall consist of minimum Board of eight and maximum twelve members including the following Management. persons, namely,-
 - (a) the Vice-Chancellor;
- (b) upto one-fourth members of the Board of Management, to be nominated by the Sponsoring Body;
- (c) eminent persons from the field of Management, Finance & Law, Science and Technology and Public Administration or such other subjects, who are not the members of the Governing Body, to be nominated by the Sponsoring Body;
- (d) persons from amongst the Heads of Departments of the University, to be nominated by the Sponsoring Body:

Provided that it shall be the duty of the Sponsoring Body, to maintain the gender parity in nominating women members in any case not less than one fourth and not more than one half of total members in the composition of the Board.

(2) The Vice-Chancellor shall be the Chairperson of the Board of Management:

Provided that in the absence of the Vice-chancellor, the Chancellor may, at his discretion, nominate any other member of the Governing Body to be the Chairperson of the Board of Management.



- (3) The powers and functions of the Board of Management shall be such as may be specified by the Statutes.
- (4) The Board of Management shall meet once in every two months.
- (5) A minimum of one-half of the members shall form the quorum for a meeting of the Board of Management.

Academic Council.

- 22. (1) The Academic Council shall consist of the Vice-Chancellor, the Registrar and such other members as may be specified by the Statutes.
- (2) The Vice-Chancellor shall be the Chairperson of the Academic Council.
- (3) The Academic Council shall be the principal academic body of the University and shall, subject to the provisions of this Act, the Statutes, the Ordinances, the Regulations and the rules made thereunder, co-ordinate and exercise general supervision over the academic policies of the University.
- (4) The quorum for meetings of the Academic Council shall be such as may be specified by the Statutes.

Disqualifications.

- 23. (1) A person shall be disqualified for being a member of any of the authorities or bodies of the University, if,-
- (a) he/she is of unsound mind and stands so declared by a competent court;
 - (b) he/she is an undischarged insolvent;
- (c) he/she has been convicted of any offence involving moral turpitude;



- (d) he/she is conducting or engaging himself in private coaching with or without pecuniary gain; or
- (e) he/she has been punished for indulging in or promoting unfair practice in the conduct of any examination, in any form, anywhere.
- 24. No act or proceedings of any authority of the University shall be invalid merely by reason of any vacancies in or defect in the constitution of any authority or body of the University.

Vacancies not to invalidate the constitution of, or the proceedings of any authority or body of the University.

25. The authorities of the University may constitute such Constitution of Committees with such terms of reference as may be necessary for specific tasks to be performed by such Committees. The constitution of such Committees, powers to be exercised and duties to be performed shall be such as may be specified by the Statutes.

Committees.

CHAPTER - V STATUTES, ORDINANCES AND REGULATIONS

- 26. (1) Subject to the provisions of this Act, and the rules First statutes. made thereunder, the First Statutes may provide for all or any of the following matters, namely:-
- (a) the constitution, powers and functions of the authorities and other bodies of the University as may be constituted from time to time;
- (b) the terms and conditions of appointment of the Vice-Chancellor, his powers and functions;



- (c) the manner, terms and conditions of appointment of the Registrar and Chief Finance and Accounts Officer, their powers and functions;
- (d) the manner and terms and conditions of appointment of other officers and teachers and their powers and functions;
- (e) the terms and conditions of service of employees of the University;
- (f) the procedure for resolution in cases of disputes between employees or students and the University;
 - (g) the conferment of honorary degrees;
- (h) the provisions regarding exemption from payment of tuition fee and awarding scholarships and fellowships to the students;
- (i) framing of policy for admissions, including regulation of reservation of seats; and
 - (j) fees to be charged from students.
- (2) The First Statutes of the University shall be made by the Governing Body and shall be submitted to the Government for its approval.
- (3) The Government shall consider the First Statutes, submitted by the University and shall approve it as far as possible within two months from the date of its receipt, with or without modifications, as it may deem necessary provided that the Government shall mention reasons for such modifications, if any.

(4) The University shall communicate its agreement to the First Statutes as approved by the Government, and if it desires not to give effect to any or all the modifications made by the Government under sub-section (3), it may give reasons thereof and after considering such reasons, the Government may or may not accept the suggestions made by the University.

- (5) The Government shall publish the First Statutes, as finally approved by it, in the Telangana Gazette, and thereafter it shall come into force from the date of such publication.
- 27. (1) Subject to the provisions of this Act and the rules Subsequent made thereunder, the subsequent Statutes of the University Statues. may provide for all or any of the following matters, namely,-
 - (a) creation of new authorities of the University;
 - (b) accounting policy and financial procedure;
- (c) representation of teachers in the authorities of the University;
- (d) creation of new departments and abolition or restructuring of existing departments;
 - (e) institution of medals and prizes;
 - (f) procedure for creation and abolition of posts;
 - (g) revision of fees;
- (h) alteration of the number of seats in different disciplines; and



- (i) all other matters which by or under the provisions of this Act require to be specified by the Statutes.
- (2) The Statutes of the University other than the First Statutes shall be made by the Board of Management with the approval of the Governing Body.
- (3) The Statutes made under sub-section (2) shall be submitted to the Government and it may approve or, if considers necessary, give reasoned suggestions for modification as far as possible within two months from the date of receipt of the Statutes.
- (4) The Governing Body shall consider the modifications suggested by the State Government and return the Statutes to it with its agreement to such changes or with its comments on the suggestions made by the State Government.
- (5) The Government shall consider the comments of the Governing Body and may approve the Statutes with or without modifications and it shall be published by it in the Telangana Gazette, and shall come into force from the date of such publication.

First Ordinances.

- 28. (1) Subject to the provisions of this Act, the rules and the Statutes made thereunder, the First Ordinances may provide for all or any of the following matters, namely,-
- (a) the admission of students to the University and their enrolment as such;
- (b) the courses of study to be laid down for degrees and diplomas of the University;





- (c) the award of degrees, diplomas and other academic distinctions, the minimum qualifications for the same;
- (d) the rules and procedures for award of fellowships, scholarships, stipends, medals and prizes;
- (e) the conduct of examinations, including the terms of office and manner of appointment and the duties of examining bodies, examiners and moderators;
- (f) fees to be charged for the various courses, examinations, degrees or diplomas of the University;
- (g) provision of various student facilities and services provided by the University including but not limited to student housing;
- (h) provision regarding disciplinary action against the students;
- (i) the creation, composition and functions of any other body which is considered necessary for improving the academic standards of the University;
- (j) the manner of co-operation and collaboration with other Universities and institutions of higher education;
- (k) such other matters which are required to be provided by the Ordinance by or under this Act.
- (2) The First Ordinances of University shall be made by the Vice-Chancellor which, after being approved by the Board of Management, shall be submitted to the Government for its approval.





- (3) The Government shall consider the First Ordinances submitted by the Vice-Chancellor under sub-section (2) as far as possible within two months from the date of its receipt and may approve it or give reasoned suggestions for modifications therein.
- The Vice-Chancellor shall modify either the incorporating the suggestions the Ordinances Government or give reasons for not incorporating any of the suggestions made by the Government and shall return the First Ordinances along with such reasons, if any, after due consideration, by the Board of Management to the Government and on receipt of the same, it shall consider the comments of the Vice-Chancellor and may approve the First Ordinances of the University with or without such modifications and it shall be published by the Government in the Telangana Gazette, and it shall come into force from the date of such publication.

Subsequent Ordinances. 29. (1) All Ordinances other than the First Ordinances shall be made by the Academic Council which after being approved by the Board of Management shall be submitted to the Government for its information and publication in the Telangana Gazette.

Regulations.

30. The authorities of the University may, subject to the prior approval of the Board of Management make Regulations, consistent with this Act the Statutes and the Ordinances and the rules made thereunder, for the conduct of business of each such authority and committees constituted by each such authority.

CHAPTER - VI REGULATION OF UNIVERSITY

31 (1) The Government may for the purpose of ascertaining the standards of teaching, examination and research or any other matter relating to the University, after consultation with the Vice-Chancellor, cause an assessment to be made in such manner as may be prescribed, by such person or persons as it may deem fit.

Powers of the Government to give directions.

- (2)The Government shall communicate recommendations to the University on the basis of such assessment for corrective action. The University shall adopt such corrective measures and make efforts so as to ensure the compliance of the recommendations.
- the University fails to comply with the (3)recommendations made under sub-section (2) within a reasonable time, the State Government may give such directions as it may deem fit for such compliance.
- 32. (1) The University shall have full autonomy, along with Admissions and full disclosure and transparency, on starting various academic programmes and the admissions process thereof, so long as it adheres fully to the admission norms that it has committed to in its approved project proposal.

Fee Structure.

- (2) In the case of an existing Institution which is established as a University under this Act the rule of reservation in admissions implemented by that Institution, for the existing seats of that Institution, shall be continued even in the University established under this Act.
- (3) The University shall have full autonomy, along with full disclosure and transparency, on setting fees for the various programmes that it decides to offer. Fees shall be determined by each University through a Fee Fixation



Committee which would consist of members drawn from Board of Management, Academic Council, as well as external members. The Fee Fixation Committee shall be headed by a member of the Board of Management.

(4) In the case of an existing Institution, which is established as a University under this Act, the Fee fixed by the Telangana Admission and Fee Regulatory Committee (TAFRC), for the courses and seats of that Institution, shall be continued even in the University established under this Act.

Domicile based reservation.

33. 25% of seats for admissions in the courses undertaken by the University shall be exclusively reserved for the students of the State of Telangana on the basis of domicile as may be prescribed.

Convocation.

34. The Convocations of the University for conferring degrees, diplomas or for any other purpose may be held in every academic year in the manner as may be specified by the Statutes.

Accreditation of the University.

35. The University shall obtain accreditation from the National Assessment and Accreditation Council (NAAC) within five years from the commencement of the programmes and courses and certification/accreditation from such other Regulating Bodies which are connected with the courses taken up by the University and inform the Government about the grade provided to the University. The University shall ensure renewal of such accreditations from time to time.

University to follow rules, regulations, norms, etc., of the regulating bodies. 36. Notwithstanding anything contained in this Act, the University shall be bound to comply with all the rules, regulations, norms, etc., of the Regulating Bodies and provide all such facilities and assistance to such Bodies as



are required by them to discharge their duties and carry out their functions.

CHAPTER - VII FUNDS OF THE UNIVERSITY

37. (1) The Sponsoring Body shall establish an Endowment Endowment Fund. Fund for the University with an amount specified in the Letter of Intent.

(2) The Endowment Fund shall be used as security deposit to ensure that the University complies with the provisions of this Act and functions as per provisions of this Act, the Statutes, the Ordinances, the Regulations and the rules. The Government shall have the powers to order forfeiture of a part or whole of the Endowment Fund in case the University or the Sponsoring Body contravenes the provisions of this Act or the Statutes or the Ordinances or the Regulations or the rules made thereunder. In such a case the forfeited amount shall be utilized for due compliance with the provisions of this Act, Statutes, Ordinances, Regulations or the rules as the case may be:

Provided that before issuing an order of forfeiture under this sub-section, the Government shall afford an opportunity of representation to the University or the Sponsoring Body as the case may be.

(3) The University, if required, may utilize 75% of the income from Endowment Fund for the development of infrastructure of the University and cannot meet the recurring expenditure of the University from it. The balance and un-utilised income shall be added to the Endowment Fund.




- (4) The amount of Endowment Fund shall be invested in such highly secure and liquid instruments and kept invested until the dissolution of the University.
- (5) The Governing Body shall be responsible and accountable for the safety and correct utilization of the Endowment Fund.
- (6) The Governing Body shall ensure that the University prepares an audited report on the status and utilization of interest proceeds of the Endowment Fund annually, which may be sought by the Government from time to time:

Provided that the University which fails to maintain such a report may be enquired into as per section 44.

General Fund.


- 38. Every University shall establish a fund, which shall be called the General Fund to which the following shall be credited, namely,-
- (a) fees and other charges received by the University for procurement and upkeep of the assets of the University;
 - (b) any contributions made by the Sponsoring Body;
- (c) any income received from consultancy and other works undertaken by the University in pursuance of its objectives;
- (d) trusts, bequests, donations, endowments and any other grants; and
 - (e) all other sums received by the University.

Application of General Fund. 39. The General Fund shall be utilized for the following objects, namely,-





- (a) for the repayment of debts including interest charges thereto incurred by the University for the purposes of this Act and the Statutes, the Ordinances, the Regulations and the rules made thereunder with the prior approval of the Governing Body;
 - (b) for upkeep of the assets of the University;
- (c) for the payment of the fee for audit of the funds created under sections 37 and 38;
- (d) for meeting the expenses of any suit or proceedings by or against the University;
- (e) for the payment of salaries, allowances, Provident Fund contributions, gratuity and other benefits to officers, employees and members of the teaching and research staff;
- (f) for the payment of travelling and other allowances of the members of the Governing Body, the Board of Management, the Academic Council, other authorities and the members of any Committee appointed by any of the authorities or the Chancellor or the Vice-Chancellor;
- (g) for the payment of fellowships, freeships, scholarships, assistantships and other awards to the students belonging to economically weaker sections of the society or research associates, trainees or, as the case may be, to any student otherwise eligible for such awards under the Statutes, the Ordinances, the Regulations or the rules;
- (h) for the payment of any expenses incurred by the University in carrying out the provisions of this Act or the Statutes, the Ordinances, the Regulations or the rules;
- (i) for the payment of cost of capital, not exceeding the prime lending rate from time to time of the State Bank of





India, incurred by the Sponsoring Body for setting up the University and the investments made therefor;

- (j) for the payment of charges and expenditure relating to the consultancy works undertaken by the University in pursuance of the provisions of this Act or the Statutes or the Ordinances or the Regulations or rules made thereunder;
- (k) for the payment of any other expenses including service fee payable to any organization charged with the responsibility of providing any specific service, including the managerial services to the University, on behalf of the Sponsoring Body, as approved by the Board of Management to be an expense for the purposes of the University:

Provided that no expenditure shall be incurred by the University in excess of the limits for total recurring expenditure and total non-recurring expenditure for the year, as may be fixed by the Board of Management, without prior approval of the Board of Management.

CHAPTER - VIII ACCOUNTS, AUDIT AND ANNUAL REPORT

Annual Report.

40. The Annual Report of the University which shall be prepared by the University shall include among other matters, the steps taken by the University towards the fulfillment of its objectives and shall be submitted to the Government.

Explanation: Financial year for the purpose of this Chapter shall be from April 1st to March 31st of the following year.

Annual Accounts and Audit.

41. (1) The Annual Accounts including Balance Sheet of the University shall be prepared by the University in a fair and



transparent manner and the Annual Accounts shall be audited at least once in every year by the Auditors appointed by the University for this purpose.

- (2) A copy of the Annual Financial Statements together with the Audit Report shall be submitted to the Government every financial year.
- (3) The Governing Body shall be responsible for accurate and detailed preparation of the Annual Financial Statements and the timely submission of the same with the Annual Report.
- (4) The advice of the Government, if any, arising out of the Accounts and Audit Report of the University shall be placed before the Governing Body. The Governing Body shall issue such directions, as it may deem fit, and compliance shall be reported to the Government.

CHAPTER - IX WINDING UP OF UNIVERSITY

42. (1) If the Sponsoring Body proposes to dissolve itself according to the provisions of the law governing its constitution, it shall give at least six months prior notice to the Government.

Management of the University on dissolution of the Sponsoring Body.

(2) The Government shall, on receipt of such notice make such arrangements as may be necessary, for the administration of the University from the date of dissolution of the Sponsoring Body till the completion of the syllabus/regular courses by the last batches of students admitted to the University and till they have been awarded degrees, diplomas or awards as the case may be. The Government may also cause the functioning of the University to continue by appointing an administrator in place of the Sponsoring Body, who shall be entrusted with the powers, duties and



functions of the Sponsoring Body as prescribed under this Act.

(3) The Government on dissolution of the Sponsoring body after due consideration, may dissolve the University in such manner as may be prescribed.

Dissolution of the University.

43. (1) The Government, after due consideration, may dissolve the University in such manner as may be prescribed:

Provided that the dissolution of the University shall have effect only after the last batches of students of the regular courses have completed their syllabus/courses and they have been awarded degrees, diplomas or awards, as the case may be:

Provided further that the Government may continue the functioning of the University by appointing an administrator in place of the Sponsoring Body entrusted with the powers and functions as per sub-section (2) of section 42.

(2) On dissolution of the University all the assets and liabilities of the Universities shall vest in the Sponsoring Body in the manner prescribed:

Provided that any specific concessions assigned by the Government to the University shall be resumed to the Government.

Special powers of the Government in certain circumstrances. 44. (1) Where the State Government is of the opinion that the University has contravened any of the provisions of this Act or the Statutes or the Ordinances or the Regulations or the rules made thereunder or has violated any of the directions issued by it under this Act or a situation of financial mismanagement or mal-administration has arisen in the University, it shall issue a notice requiring the





University to show cause within forty-five days as to why an administrator shall not be appointed.

- (2) On receipt of reply of the University on the notice issued under sub-section (1), if the Government is satisfied that there is a prima facie case of contravention of any of the provisions of this Act or the Statutes or the Ordinances or the Regulations or the rules made thereunder or violation of directions issued by it under this Act or there is financial mismanagement or mal-administration, it shall make an order of such inquiry as it may consider necessary.
- (3) The Government shall, for the purposes of any such inquiry under sub-section (2), appoint an inquiry officer or officers to inquire into any of the matters as per sub-section (1) and to make report thereon.
- (4) The inquiry officer or officers appointed under subsection (3) shall have the same powers as are vested in a Civil Court under the Code of Civil Procedure, 1908 while Central Act No.5 of trying a suit in respect of the following matters namely,-

- (a) summoning and enforcing the attendance of any person and examining him on oath;
- (b) requiring the discovery and production of any such documents or any other material as evidence;
- (c) requisitioning any public record from any court or office.
- (5) On receipt of the inquiry report from the officer or officers appointed under sub-section (3), if the Government is satisfied that the University has contravened all or any of the provisions of this Act or the Statutes or the Ordinances or the Regulations or the rules made thereunder or has violated any of the directions issued by it under this Act or a



situation of financial mismanagement and maladministration has arisen in the University which threatens the academic standards of the University, it may appoint an administrator.

- (6) The administrator appointed under sub-section (5) shall exercise all the powers and perform all the duties of the Governing Body and the Board of Management under this Act and shall administer the affairs of the University until the last batch of the students of the regular courses have completed their courses/syllabus and they have been awarded with degrees, diplomas or awards as the case may be.
- (7) After having been awarded the degrees, diplomas or awards as the case may be to the last batches of the students of the regular courses or after the transfer of all the students to other institutions, if applicable, the administrator shall make a report to that effect to the Government.
- (8) On receipt of the report under sub-section (7), the Government after due consideration, may decide to continue the functioning of the University by vesting the powers of the Governing Body in the prescribed manner to other societies having similar objectives or the Government may decide to dissolve the University in such manner as may be prescribed.

CHAPTER - X MISCELLANEOUS

Powers of the Government to make rules.

- 45. (1) The Government may by notification in the Telangana Gazette make rules to carry out the purposes of this Act.
- (2) In particular and without prejudice to the generality of the foregoing powers, such rules may provide for all or any of the following matters namely:-



- (a) the manner of making proposal and Project Report to establish the University under sections 6 and 7;
- (b) other matters relating to the Statutes and Ordinances under sub-section (1) of section 26, section 27, section 28 and section 29;
- (c) matters relating to dissolution of the Sponsoring Body under sub-section (2 and 3) of section 42;
- (d) matters relating to dissolution of the University under sub-section (1) of section 43 and section 44.
- (3) Every rule made under this Act shall, immediately after it is made, be laid before the Legislature of the State, if it is in session and if it is not in session, in the session immediately following for a total period of fourteen days which may comprise in one session or in two successive sessions and if, before the expiration of the session in which it is so laid or the session immediately following, the Legislature of the State agrees in making any modification in the rule or in the annulment of the rule, the rule shall, from the date on which the modification or annulment is notified, have effect only in such modified form or shall stand annulled as the case may be, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule.
- 46. (1) If any difficulty arises in giving effect to the provisions of this Act the Government may, by order published in the Telangana Gazette, make provisions not inconsistent with the provisions of this Act, as appear to it to be necessary or expedient for removing the difficulty:

Powers to remove difficulties.

(2) Every order made under this section shall, as soon as may be after it is made, be laid before the State Legislature.

MEMORANDUM OF ASSOCIATION

OF NATIONAL INSTITUTE OF CONSTRUCTION MANAGEMENT AND RESEARCH

1. NAME

The name of the Society shall be NATIONAL INSTITUTE OF CONSTRUCTION MANAGEMENT AND RESEARCH. For the sake of brevity, it shall be referred to as NICMAR.

2. ADDRESS

The Registered Office of the Society shall be situated at Mumbai in the state of Maharashtra at Walchand Centre, Walchand Terraces, Tardeo, Mumbai 400034.

3. OBJECTS

The Society shall exist for the service of the construction and allied industries and for increasing its relevance to the national good and international standards. The Society is formed not for purpose of profit. The objects for which the Society is established are:

- a. To engage in activities for the promotion of education, training, research, professionalism and skill formation at all levels of the construction and other allied industries.
- b. To undertake special projects and activities in various parts of India to promote management and professional training in construction and other allied industries.
- c. To work independently or jointly in collaboration with other Trusts/ Societies, Institutions, Associations, Governmental and non-Governmental Organisations, International bodies on projects aimed at attaining the objects of NICMAR.
- d. To disseminate, through Seminars, Symposia, Workshops, Conferences, Lectures, Publications and other means, knowledge concerning all matters relating to construction and other allied industries.
- e. To publish study materials, periodicals, reports and other literature relating to construction and other allied industries.
- To undertake research for advancement of technology and management in construction and other allied industries.

- g. To undertake consultancy, set up consultancy centres of its own and/or in collaboration with other organizations in the areas of construction management and other allied subjects.
- h. To conduct research, training, organise conferences, seminars etc. and to undertake such activities as are necessary for rural development, rural infrastructure, public health, human resources development and other allied matters.
- To take such actions as are incidental to or conducive to the attainment of all or any of the objects of the Society.

If any of the purpose mentioned above fails to qualify as charitable purpose under the Income tax Act, 1961 or any other statutory modification thereof for the time being in force, it shall be deemed that such non qualifying purpose has been deleted from clauses (a) to (i) above from the date on which such purpose ceases to qualify as charitable purpose.

RULES AND REGULATIONS

OF

NATIONAL INSTITUTE OF CONSTRUCTION MANAGEMENT AND RESEARCH

- 1.0 In these Rules unless there be anything in the context repugnant thereto or consistent therewith:
 - a. The 'Society' means NATIONAL INSTITUTE OF CONSTRUCTION MANAGEMENT AND RESEARCH. For the sake of brevity, it shall be called NICMAR.
 - b. 'Board of Governors' means the body which under these regulations is constituted to be the Board of Governors of the Society and which shall be refer to as "The Board".
 - c. 'Chairman' means the Chairman of the Board of Governors.
 - d. 'Director General' means the Director General of the Society.
 - e. 'Director' means the Director of the Institute.
 - f. 'Secretary' means the Secretary of the Society and the Board of Governors/Board of Trustees.
 - g. 'Registrar' means the Registrar of Societies, Maharashtra State.
 - h. 'Act' means the Societies Registration Act., 1860.
 - i. 'Month' means calendar month.
 - j. 'Trustees' means the Trustees of the Society.
 - k. Words imparting the 'singular' number shall be deemed to include the plural and words imparting 'masculine' gender shall be deemed to include the feminine gender and viceversa.

2.0 MEMBERSHIP

There shall be the following categories of membership:

- i. Founder Members
- ii. Patron Members
- iii. Corporate Members
- iv. Institutional Members
- v. Associate Professional Members

3(i) Founder Members

The Signatories to the memorandum and Rules and Regulations of the Society and those whose names are mentioned in the Appendix - A of the rules and regulations of the society shall be the Founder Members of the Society.

3(ii) Patron Members

A person of repute, or any corporate body or an Authority in the Public/Private sector, who subscribes to the objects of the Society and pays the subscription of Rs. 5,00,000 (Rupees Five lacs only) as per the byelaws of the society may be admitted as a Patron Member.

3(iii) Corporate Members

A Corporate body/firm/industrial/business organization / Professional Institution / government department/ Public Undertaking/ Municipality / Development Authority Board, which fosters or which subscribes to the objects of the society and agrees to pay an annual subscription of Rs. 1,00,000 (Rupees One lac only) per annum for a period of 5 years as per the bye-laws of the society may be admitted as Corporate Members.

3(iv) Institutional Members

An Educational or Research institute and/or consultancy firm / professional / training institutions which subscribe to the objects of the Society and agrees to pay a subscription of Rs. 5000/- (Rupees Five thousand only) per annum as per the bye-laws of the society may be admitted as Institutional Members.

3(v) Associate Professional Members

An alumni of NICMAR institutions who has graduated from any of its qualification programme of studies and also holds graduate degree from any recognised Indian or foreign university or an equivalent qualification on completion of 2 years professional experience from the date of award of NICMAR degree/diploma/certificate and who subscribes to the objects of the Society and agrees to pay an annual subscription of Rs. 1,000 (Rupees One thousand only) or as decided by the Board of Trustees as per the bye laws of the Society, may be admitted as Associate Professional Member.

- **4(i)** Application for any category of membership shall be made in the form prescribed for the purpose by the Society and shall be accompanied by prescribed subscription.
- **4(ii)** The Board of Trustees from time to time, may alter the rate of subscription of the categories of members stated above, after giving due notice to the members.



- **4(iii)** A subscription for the year per annum shall, for the purpose of the rules, be from the first day of April until the last date of March following.
- 5.0 All applications for admission to the various categories of the membership of the Society shall be decided by the Board of Governors. The decision shall be communicated to the applicants within one month from the date of the meeting of the Board, at which such decision is taken.

The decision of the Board in this respect shall be final. However, the decision of admission of Patron Members shall be subject to ratification by the Board of Trustees.

6.0 The members admitted in accordance with the provisions of the rules and regulations of the society are entitled to their rights upto the end of accounting year of the society and thereafter they shall pay their yearly membership subscription within a period of 90 days from the date of close of the financial year.

In the case of failure to pay yearly membership subscription within the stipulated time, in accordance with the provisions of the Rules and Regulations of the Society, the said member shall cease to be the member of the Society and his/its name shall be removed by the Board from the membership register for which no notice is required to be given to the member.

- 7.0 Any member of the Society may indicate by notice in writing his/its desire to resign from primary membership and the said member shall cease to be a member upon acceptance of its/his resignation by the Board.
- Any member who for any reason ceases to be a member shall nevertheless remain liable to pay the sum and all dues which, at the time of his/its ceasing to be a member, may be due to Society.

Any member whose membership is terminated during any year shall not be entitled to any rebate or proportionate reduction in subscription already paid or payable for that year, irrespective of the date on which his/its membership is terminated.

9.0 The Society shall maintain at its Registered Office a list of persons who are members within the meaning of Section 15 of the Societies Registration Act, 1860, in the form of Schedule VI of the Societies Registration (Maharashtra) Rules 1971 vide Rules thereof. The same shall be open for inspection by the Members on such dates and time as may be fixed by the Secretary on application in writing to be made by the members and addressed to the Society.



No member shall be entitled to take copies of/or extracts from the Register.

10.0 All members shall be entitled to attend all General Meetings and Extra-Ordinary General Meetings of the Society and shall be entitled to receive copies of the reports of the Society.

11.0 A. ANNUAL GENERAL MEETINGS

A general Meeting of the Society shall be held at least once in every calendar year which shall be called Annual General Meeting and not more than 15 months shall elapse between two successive Annual General Meetings.

All other General Meetings shall be called Extra Ordinary General Meetings.

B. MEETINGS HOW CONVENED

The Annual General Meetings shall be convened by the Secretary and shall be held at such date and time and place as the Board of Governors may decide.

C. NOTICE

Fourteen days' clear notice for holding the Annual General Meetings shall be given in such manner as the Board of Governors may decide.

D. VOTING RIGHTS

Members of Society shall have voting rights which may be exercised in person or by proxy, such authority to be filed with the Secretary at least 24 hours before the time of the General Meeting.

E. QUESTIONS TO BE DECIDED BY MAJORITY VOTERS

Every Question submitted to a General Meeting shall be decided by a majority of votes and in case of a tie, the Chairman of the meeting shall have a second or casting vote.

In all cases, voting shall be by show of hands in the first instance. Where the Chairman so decides there may be a poll and the poll shall be held in such manner as the Chairman may decide.

F. CHAIRMAN OF MEETINGS

The Chairman of the Board of Governors, if present shall preside at all General Meetings. In the absence of the Chairman, the members present having voting rights, may elect one of them to be the Chairman of the Meeting.



G. QUORUM

Unless otherwise decided at a General Meeting, the quorum of General Meeting shall be five members having voting rights, present in person.

H. RESOLUTION

A declaration by the Chairman that Resolution has been carried or lost and an entry to that effect in the books of proceedings of the Society shall be conclusive evidence of that fact.

I. ADJOURNED MEETINGS

If at a General Meeting convened otherwise than on requisition, a quorum is not present within 30 minutes of the time of commencement of the meeting, the same shall stand adjourned and reconvened one hour later at the same place. At such adjourned meeting the voting members present shall be competent to transact the business of the meeting irrespective of whether a quorum is present or not.

If in respect of a meeting convened on requisition, the quorum is not present within 30 minutes of the time of commencement thereof, the meeting shall stand dissolved.

12.0 EXTRA-ORDINARY GENERAL MEETING

- A. The Chairman on his own accord or the Board of Trustees at its own accord or on the written requisition of not less than 1/4 of the voting members of the Society may call an Extra-Ordinary General Body Meeting.
- B. Fourteen days' clear notice shall be required for such a meeting. The requisition so made by the members of the society shall express the object for which the meeting is proposed to be called.
- C. At an Extra Ordinary General Body Meeting, no subject other than that stated in the notice or the requisition, as the case may be, shall be discussed except with the permission of the Chairman.
- D. All regulations applying to General Meeting will mutatis mutandis apply to Extra-Ordinary General Body Meetings.
- 13.0 The income and property of the Society, howsoever derived, shall be applied towards the promotion of the objects as set forth in this Memorandum of Association subject nevertheless in respect of the expenditure of grants or donations made with any specific conditions as may



be imposed from time to time by the donors. No portion of the income and property of the Society shall be paid or transferred, directly or indirectly, by way of dividends, bonus or otherwise, however, by way of profits to any person/persons, who at any time are, or have been members of the Society or to any person claiming through them, or any of them provided that nothing herein contained shall prevent the payment in good faith of remuneration to any member or other person in return for any service rendered to the Society.

- A. The Board of Trustees shall cause to be maintained proper books of accounts, of the Society as required by the Act and shall have the accounts audited by a duly qualified Chartered Accountant annually to be appointed at the Annual General Meeting.
 - B. The Auditors shall prepare a balance sheet at the end of every financial year and submit a report showing the state of financial affairs of the society. The Balance Sheet and Auditor's Report shall be placed at the Annual General Meeting of the Society for adoption.
 - C. The Auditors shall also prepare Income and Expenditure Accounts of the activities and projects run by the society at different places separately and those accounts shall be incorporated in the accounts of the Society.

15.0 A. BOARD OF GOVERNORS

The Board of Governors of the Society shall consist of not less than five members. The membership of the Board of Governors shall consist of the following:

- i. Not more than five members nominated by the Board of Trustees.
- ii. Not more than five members elected at the Annual General Meeting from amongst the Founder, Patron and Corporate members of the Society.
- iii. Not more than four persons to be co-opted by the Board of Governors.
 However, no action of the Board of Governors will be invalidated by the mere fact that the co-option of the four members, as prescribed above, had not been made.
- iv. Director General and or Managing Trustee of the Society, shall be ex-officio members of the Board and shall have the right to vote at all meetings.
- v. The Chairman of the Board of Trustees, if he/she is other than the Chairman of the Board of Governors, shall be ex-officio member of the Board of Governors and shall have a right to vote at all meetings.



B. The first Board of Governors shall consist of seven members whose names are set out in the Memorandum of the Society which shall include:

C. The term of office of the first Board of Governors shall be for a period of three years from the date of registration of the said society.

On the expiry of the term of three years of the first Board of Governors, and after every three years thereafter, a new Board of Governors shall be constituted as per the bye-laws of the Society.

The retiring members of the Board of Governors, if eligible, may offer themselves for reelection.

The Board of Governors in office shall continue to function till a new Board of Governors is constituted as per the rules and regulations of the society.

In the event of the number of members of the Board of Governors at any stage being reduced, to below five, as a result of vacancies, an Extra-ordinary General Meeting of the Society shall be called, as early as practicable, by the then Board of Governors to fill in the vacancies.

- D. Additional members may be co-opted by the Board of Governors, as it may, from time to time, determine.
- E. A vacancy in membership of the Board of Governors will arise due to resignation by, or on death, of any member or on his becoming of unsound mind insolvent or being convicted of a criminal offence involving moral turpitude.
- F. A vacancy in the office of any member of the Board of Governors may be filled up by the remaining members of the Board of Governors. Any person so chosen shall retain his office so long only as the vacating member would have retained the same if no vacancy had occurred.



G. POWER OF THE BOARD OF GOVERNORS

The Board of Governors may discharge such functions, and enjoy such powers as are delegated to it by the Board of Trustees, from time to time. The Board of Trustees may review any or all decisions of the Board of Governors, if in its opinion such decisions are not in furtherance of, or in conformity with the objects of the Society.

Without prejudice to the general powers conferred on the Board of Governors by the Board of Trustees, it is hereby expressly declared that the Board of Governors shall have and exercise the following powers subject to the provisions of the Act.

- To execute the general policies of the Society, in conformity with the objects of the Memorandum of Association of the Society.
- ii. To consider the annual reports and audited accounts for the previous year and the budget estimates for the ensuing year and to pass resolutions thereon:
- iii. To appoint auditors.
- iv. To open the accounts of the Institute's with any one of the Scheduled Banks and to prescribe the procedure for the operation thereof;
- v. To consider and make decision on matters relating to the objects, administration and finance of the Institute's.
- vi. To review the proceedings of the meetings of Management Council of the Institutes.
- vii. To delegate such powers of appointment to the Chairman, or any other authority or authorities or officer of the Society.
- viii. To manage and regulate the finance, accounts, investments, movable property, business and all other administrative affairs of the Institutes and, for that purpose, to appoint such agents as it may think fit;
- ix. Consistent with the provisions of the objects clause in the Memorandum of Association, to receive grants, donations, gifts, prizes scholarships, fees and other monies; to give grants, and donations, to award prizes, scholarships, etc.
- x. To transfer or accept transfer of any movable property on behalf of the Institutes and to appropriate, exchange, alienate, sell or in any other manner dispose off, all or any of it assets or property, with concurrence and approval of the Trustees.



- xi. To advise the Trustees regarding the acquisition, management and disposal of any immovable property on behalf of the Institute.
- xii. To institute and/or defend any suit, civil or revenue proceeding, criminal case, or complaint or a legal action of any description whatsoever.
- xiii. To exercise such other powers not otherwise provided for and to perform such other duties as may be necessary for the proper functioning of the Institutes; and
- xiv. To delegate all or any of its powers to a member of the Board or other authority or authorities or officer in the interest of the proper working of the Institutes and the expeditious disposal of business thereof.

15.0 H. BOARD OF TRUSTEES

The Society is a Public Trust within the meaning of Section 2 (B) of the Bombay Public Trust Act 1950.

The following Seven signatories to the Memorandum of Association at the time of registration under Societies of Registration Act, 1860 and the rules framed there under, shall be the first Board of Trustees of the said society.

- I. Any vacancy which may arise in the Board of Trustees due to the resignation by, or death of any member, or on his becoming of unsound mind, insolvent or being convicted of a criminal offence involving moral turpitude, shall be filled in by the Board of Trustees, by invitation only.
- J. A Trustee may be nominated on the Board of Governors or on the Management Council of an Institute/s under the NICMAR Society, and shall on appointment, exercise all the functions, powers, rights and privileges of such members.
- K. The Board of Trustees shall exercise, perform, duties, powers functions and rights of NICMAR society as also those necessary or consequential and incidental to the carrying out of the objects of NICMAR.

The Board of Trustees may meet whenever they deem it necessary to conduct the business of the Society and may frame rules and regulations

L. The Board of Trustees shall hold and be responsible for all assets and liabilities of the Society:

All powers for the control, management and administration of the properties funds and affairs of the Society shall vest in the Board of Trustees.

The Board of Trustees shall have the power to acquire and to accept the transfer of any immovable/movable property on behalf of and for the purpose of the Society and the Institute/branches established by the Society.

- M. Without prejudice to the general powers conferred on the Board of Trustees, it is hereby expressly declared that the Board of Trustees shall have and exercise the following powers subject to provisions of the Act.
 - To establish, maintain or close or open Institutes and/or branches of NICMAR Society or to grant or cancel affiliations to any other Institutes in furtherance of the objects of the Society.
 - To appoint Director General/Directors of the Institute/s under the NICMAR Society.

- iii. Consistent with the provision of the object clause in the Memorandum of Association and on such terms and subject to such conditions, as it may think proper, the trustees have power to accept grants, donations, contributions, gifts, prizes, scholarship fees and other monies, and to give grants, donations, to award prizes, scholarships, subscriptions and endowments.
- iv. To accept grants from Central Government, State Governments, Local authorities, Universities, Institutions, Industries, Associations, Development Authorities/Board established by Central or State governments, or Autonomous bodies of Central or State governments, Individuals on such terms of conditions as may be mutually agreed upon.
- v. To purchase, take on lease or in exchange, hire or otherwise acquire, dispose off or mortgage or otherwise deal, with the real or personal property and any rights or privileges which the Board of Trustees of the Society may think necessary or convenient or expedient for the purpose of its objects.
- vi. To improve, manage, develop, grant rights or privileges in respect of, or otherwise deal with all or any part of the property and rights of the Society.
- vii. To borrow monies on such terms and conditions as may be agreed to by the Board of Trustees.
- viii. To consider annual budget and subsequent alterations placed before it, by the Board of Governors, from time to time and adopt it with such modification as it may think fit.
- ix. To appoint by resolution or by Power of Attorney one or more member, to execute and register documents, on behalf of the Board of Trustees.
- x. To donate or alienate any asset or any part of the corpus of the Society for the objects of the Society on such terms and conditions as the Board of Trustees, as its discretion, may think fit and proper.
- xi. To appoint committee or committees to run the administration of the Society/ Society's institutions consisting of such persons as it may decide, at its absolute discretion, in accordance with the rules and regulations of the Society and the provisions of the Act and to delegate or withdraw, any of its powers to such committee/s in the interest of the society.



- xii. To make, amend or repeal any bye-law or regulation relating to and including the administration and management of affairs of the Society or the Institutes which are not repugnant to these regulations.
- xiii. To enter into any arrangement with any Government authorities, Municipal, Local or otherwise, or any person or company or any Development Authority / Boards established by Central or State governments, that it may deem conducive to the objects of the Society, or any of them, and to obtain from such Governments, authority, person, or company any rights, privileges, charters, contracts, licenses and concessions which it may think fit and / or desirable to obtain and to carry out, exercise and comply therewith.
- xiv. Generally to do things as it may consider necessary or expedient for the purpose of carrying out the objects of the Society.

16.0 MANAGEMENT COUNCIL OF THE INSTITUTE

Any Institute sponsored by the Society shall have a Management Council. The Management Council shall be constituted by the Board of Governors and its composition shall consist as stated below:

A. Composition:

The Management Council shall consist of the following members, namely:

- i. Five members to be nominated by the Board of Governors at their discretion.
- One member to be elected from amongst themselves by faculty of the Institute concerned.
- iii. Director of the Institute.
- iv. Four members to be co-opted to the Managing Council by the other seven members stated in categories a, b and c of this para.
- v. Director General

The Director of the Institute shall be the Secretary of the Managing Committee of his Institute.

B. Chairman:

The members of the Management Council shall elect a chairman from amongst the five members nominated by the Board of Governors by a majority vote and the chairman shall hold the office for three years.

In the event the chairman of the Management Council is not present at the meeting, the members present at the meeting will elect a chairman for conducting the meeting from the members present.

C. Ouorum:

Five members of the Management Council present at the meeting shall form a quorum. The members will meet as often as is necessary to discharge the duties related to the Institute.

If at a meeting a quorum is not present within 30 minutes of the time for commencement of the meeting, the same shall stand adjourned and reconvened after one hour at the same place. At such adjourned meeting the members present shall be competent to transact the business of the meeting irrespective of whether a sufficient quorum is present or not.

D. Decision:

The Decision of the majority shall be binding on the Council and, in the event of a tie, the Chairman of the meeting shall have a casting vote.

E. Powers:

The Management Council may discharge such function and enjoy such powers, as are delegated to it by the Board of Governors, from time to time.

The Board of Governors may review and/or revise any or all, the decisions of the Management Council, if in its opinion such decisions are not in furtherance of, or in conformity with the objects of the Society.

16.1 ACADEMIC COUNCIL

The Academic Council will comprise of all the full time faculty members of the Institute and will be chaired by Director General NICMAR. It will exercise all the power and functions as have been laid down at present. The Academic Advisory Council will advise the Institute on all academic matters referred to it. The Academic Advisory Council will therefore will be an Advisory body. It will be chaired by the Director General, NICMAR. The council will comprise of following members:

- 1. Director General Chairman
- 2. Director / Dy. Director / Deans of all schools / Campuses
- 3. Five educationalists of repute from outside NICMAR
- 4. Seven persons from Industry including Construction Industry

There is no fixed schedule of meetings for the Academic Advisory Council. It will be convened on need basis. All members are appointed for a three years term by the Board of Governors.

The Academic council shall lay down standards and curricula of various academic programmes offered / taken up by the institutes, monitor all teaching, training and research work, supervise admissions to and examinations of all courses and do quality audit of all academic work.

The duties and functions of the Academic Council as well as the method of its constitution shall be in conformity with those prescribed by the national and relevant accreditation body. The same is presented as Appendix B at the end.

17.0 SUITS BY AND AGAINST THE SOCIETY

The Society shall sue and be sued in the name of the Secretary of the Society.

18.0 COMPLIANCE OF STATUTORY REQUIREMENTS

The Compliance of Statutory requirements shall be made within the time and in the manner prescribed under the Act and the Rules, if any, framed there under.

19.0 PROCEEDINGS OF THE BOARD OF GOVERNORS MEETINGS

- A. The Board of Governors shall meet at least once in six months or earlier, if necessary.

 Presiding Authority of Meetings of the Board of Governors
- B. The Chairman shall preside over every meeting of the Board of Governors. If the Chairman is not present, the members present shall choose one of them to be the Chairman of the meeting.

Quorum:





- C. Three Members of the Board of Governors present in person shall constitute a quorum at any meeting of the Board of Governors.
- D. If at a meeting a quorum is not present within 30 minutes of the time for commencement of the meeting, the same shall stand adjourned and reconvened after one hour at the same place. At such adjourned meeting the members present shall be competent to transact the business of the meeting irrespective of whether a sufficient quorum is present or not.

Notice of the Meetings of the Board of Governors.

E. Not less than seven clear days notice of every meeting of the Board of Governors shall be given to each member of the Board of Governors who is for the time being in India.

A meeting may, however, be called at shorter notice.

- If the members of the Board of Governors unanimously agree to waive the objection or
- ii. If the Chairman thinks that there is an emergency and a meeting should be immediately called.

How convened

F. A meeting of the Board of Governors shall be convened by the Secretary at least once in six months. However, that not more than six months should elapse between any two meetings of the Board of Governors.

Questions to be decided by majority vote.

- G. All questions at a meeting of the Board of Governors shall be decided by a majority of votes and in case of a tie, the chairman shall have a casting vote.
- H. A declaration by the Chairman that a Resolution has been carried or lost and an entry to that effect in the books of proceedings of the Society shall be conclusive evidence of that fact.

Business by Circulars'

I. Any business which may be necessary for the Board of Governors to transact (except such as may be placed before its Annual General Meetings) may be transacted by circulation among all its members and any resolution so circulated and approved by two-third of the members signing the circular shall be as effectual and binding as if such resolution had been passed at a meeting of the Board of Governors.

Minutes Book to be kept.

- J. Proceedings of all meetings of the Board of Governors shall be duly recorded in the Minutes Book to be kept for the purpose.
- 20.0 The Board of Governors shall function notwithstanding any vacancy and no act or proceedings of the Board of Governors shall be invalidated merely by reason of the existence of a vacancy or vacancies among its members or if any defect in the appointment or election of any of its members.

21.0 ALTERATION, EXTENSION OR ABRIDGEMENT OF THE OBJECT OF THE SOCIETY.

Whenever it shall appear to the Board of trustees of the Society that it is advisable to alter, extend or abridge the objects of the society to or for the other objects within the meaning of the Act, or to amalgamate the Society, the Board of Trustees shall submit the proposal to the members of the society in a written or printed report and shall convene an Extra-Ordinary General Meeting for the consideration thereof according to the Regulations of the Society. No such proposal shall be carried into effect unless such reports shall have been delivered or sent by post to the members of the Society ten days previous to the Extra-Ordinary General meeting convened by the Board of Trustees for the consideration thereof nor unless such proposal shall have been agreed to by the votes of the three fifth of the members delivered in person or by proxy and confirmed by the votes of three-fifth of such members present at the Second Extra-Ordinary General Body Meeting convened by the Board of Trustees at an interval of one month after the former meeting.

22.0 BANKERS

The moneys of the Society shall be paid to its credit at any Bank or Banks named by the Board of Governors. All cheques shall be signed by the Secretary/Director General/Director or any other person duly authorised by Board of Governors and either by the Chairman or a member of the Board of Governors so authorised.

22.1 INVESTMENTS

The Society may, from time to time and as and when the situation arises, invest it's monies in any scheme specified under Section 11 of the Income Tax Act, 1961 and as per the rules and regulations laid down by the Bombay Public Trusts Act, 1950. Any such investment shall be initiated only with the prior approval of the Board of Trustees and all documents in this regard shall be signed by any two members of the Board of Trustees or by any one of the

Trustees along with the Director General. After the first investment in such scheme is made in the above mentioned manner, any subsequent investment may be made by the Director General along with any of the Directors / Deputy Directors / Deans. Any unexpected premature liquidation or withdrawal from any such scheme shall be authorized by any two members of the Board of Trustees or by any one Trustee along with the Director General."

23.0 OFFICERS OF THE SOCIETY

- A. The officers of the Society will be:
 - i. The Chairman of the Board of Trustees
 - ii. The Executive Director
 - iii. The Director General
 - iv. The Secretary
- B. The members of the Board of Governors shall elect a Chairman from amongst them by a majority vote and the chairman shall hold office for three years. Thereafter, the chairman shall be elected for a three year term by the members of the Board of Governors. Any vacancy in the office of the chairman for any reason whatsoever shall be filled in by the Board by electing a member of the Board to the office and he shall hold the office for the remaining period of three years.
- C. The Director General shall be appointed by the Board of Trustees. He shall be an academician/professional of national and international repute with vision and proven ability to administer and develop the work of the Society. The Director General shall be a voting member of the Board of Governors and will be invited to the meetings of the Board of Trustees and to the Annual General Meetings and Extra-Ordinary General Body Meetings. The terms of office of the Director General may be determined by the Chairman.

The Director General shall have the right to vote at the Meetings of the Board of Governors and General Body Meetings of the Society.

- D. The Directors will be Ex-officio members of the Board of Governors and may be invited to attend the meetings of the Board of Governors and the General meetings but will not have the right to vote at these meetings.
- E. The Registrar of the Society or any other person appointed by the Chairman to function as Secretary shall be the Secretary of the Society and shall be invited to attend the Board and the General Meetings without the right to vote.

24.0 DUTIES OF THE CHAIRMAN

The Chairman of the Board of Governors when present, shall preside at the General and Board of Governors meetings and conduct the meeting as per Rules and Regulations of the Society. The Chairman will also be responsible jointly with the Director General and the Secretary for the proper accounts and records of the Society/Board of Governors.

25.0 DUTIES OF THE SECRETARY OF THE SOCIETY

The Secretary shall maintain records of proceedings of the Society and of the Board of Trustee and shall perform such other duties as the Chairman of the Board of Trustees may be general or special orders, direct.

26.0 DUTIES OF DIRECTOR GENERAL

The Director General shall be the Chief Executive of the Society. He/she shall provide academic leadership to institutions of the Society, exercise overall superintendence and control over the affairs of the Society and its institutions, appoint staff and represent the Society in all matters in furtherance of the objectives of the Society.

- 27.0 The Director General shall also be the academic and administrative head of the Institute and shall be responsible for the general superintendence, administration, maintenance of proper accounts of the Institute of the Society, submission of certified statements to the Board and Auditors.
- 28.0 The Accounts of the Society shall be properly kept showing the Income and Expenditure of the Society for the Financial year ending 31st March, every year. For every year ending as on 31st March, a statement of Income and Expenditure shall be prepared and also a Balance Sheet of the Society showing the Assets and Liabilities of the Society as on 31st March.

29.0 POWER TO ALTER REGULATIONS

A General Meeting of the Members of the Society shall have power to add, alter amend or delete any of these regulations by a three-fifth majority provided that due notice of such proposed alterations etc. is given to all the members of the Society atleast seven days before the date of the meeting. A copy of such additions, alterations, deletions or amendments to the regulations shall be filed with the Registrar within two months after they are made. In this regard the provisions of Societies Registration Act, 1860 will apply.





30.0 DISSOLUTION

If on winding up or the dissolution of the Society, there shall remain after the satisfaction of its debts and liabilities, any property whatsoever the same shall not be paid to or distributed among the members of the Society or any of them but shall consistently, with the objects of the Society, be dealt with in such manner as the society may determine, provided however, that the assets are used in such manner as to further the objects for which the society is established. Its assets may be given to a registered, society with similar objects. In this regard the provisions of Section 13 and 14 of the Societies Registration Act, 1860 will apply and the procedure laid down therein will be followed.

31.0 CUSTODY OF DOCUMENTS

The Board of Trustees shall keep all important documents such as title deeds, securities and investments etc. in safe deposit and/or with a Scheduled Bank and to execute a power of attorney in favour of Bank for realisation of interest or dividends to the credit of the Society's Account. The Board of Trustees shall be entitled to transfer such securities and investments to the name of the Bank, if they so desire.

32.0 GENERAL

The members of the Board of Governors may reimburse themselves and pay and discharge out of the Society's properties all expenses incurred in or about the execution of the society or powers of these presents. Any member of the Board of Governors being a Solicitor or engaged in any profession shall be entitled to charge and be paid all usual professional charges for the work done by him or his firm in relation to the Society.

- 33.0 The Board of Governors shall have full power to compromise all differences and disputes touching the Society's property and/or the Society's Estate and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Society's Property and/or the Society's estate and to do all other acts, deeds and things as fully and effectively being liable for any loss occassioned thereby.
- 34.0 All the provisions of the Societies Registration Act XXI of 1860 will apply to this Society.

ACADEMIC COUNCIL

The Academic Council shall be the principal academic body of the Institute and shall, in addition to all other powers and duties vested in it, have the following powers and duties, viz:

- i. To exercise general supervision over the academic work of the institute and to give direction regarding methods of instructions, evaluation or research or improvements in academic standards,
- ii. To promote research within the Institute, acquire reports on such researches from time to time,
- iii. To consider matters of academic interest either on its own initiative or at all the instance of the Board of Governors and to take proper action thereon.
- To make arrangements for the conduct of examinations in conformity with the bye-laws, iv.
- To maintain proper standards of the examinations, v.
- To recognize diplomas and degrees of Universities and other institutions and to determine vi. equivalence with the diplomas and degrees of the Institute,
- To prescribe courses of study leading to degrees and diplomas of the Institute, vii.
- To appoint examiners, moderators, tabulators and such other personnel for different viii. examinations,
- To suggest measures for departmental and inter-campus coordination, ix.
- x. To make recommendations to the Board of Governors on:
 - a. Measures for improvement of standards o teaching, training and research,
 - b. Institution of Fellowships, Traveling Fellowships, Scholarships, Medals, Prizes, etc.
 - c. Establishment or abolition of departments / centers, etc. and
 - d. Bye-laws covering the academic functioning of the Institute, discipline, residence, admissions, examinations, award of fellowships and studentships, freeships, concessions, attendance, etc.
- xi. To appoint sub-committees to advise on such specific matters as may be referred to it by the Board of Governors,
- xii. To consider the recommendations of the sub-committees and to take such action (including making of recommendations to the Board of Governors) as the circumstances on each case may require,
- xiii. To take periodical review of the activities of the Departments/Centres and to take appropriate action (including making of recommendations to the Board of Governors) with a view to maintaining and improving the standards of instruction,
- To exercise such other powers and perform such other duties as may be conferred or imposed xiv. upon it by the rules and bye-laws,
- XV. To recommend institution of Teaching posts, Professors, Readers, Lecturers to the Board of Governors.

The following Act of the Telangana Legislature, received the assent of the Governor on the 6th July, 2024 and the said assent is hereby first published on the 30th July, 2024 in the Telangana Gazette for general information:-

ACT NO. 11 OF 2024.

AN ACT FURTHER TO AMEND THE TELANGANA STATE PRIVATE UNIVERSITIES (ESTABLISHMENT AND REGULATION) ACT, 2018.

Be it enacted by the Legislature of the State of Telangana in the Seventy-Fifth Year of the Republic of India, as follows:-

A. No. 73



Short title and Commencement.

- 1. (1) This Act may be called the Telangana State Private Universities (Establishment and Regulation) (Amendment) Act, 2024.
 - (2) It shall come into force at once.

The RA is calculated on the basis of weighted scores of the cumulative academic performance along with work experience (wherever applicable) obtained from the documents submitted to NUCS by the candidates.

Selection of candidates is done on the basis of merit. The merit list is drawn on the basis of performance in MAT/CAT/ATMA etc. exam, GD, PI and RA. Admission offer letters are issued in the order of merit.

Candidates' preference of programme will be considered, but the allotment will be done at the sole discretion of the admission department, NUCS, Hyderabad, Telangana. Candidates should appear for the selection procedure on the given dates.

Out of the total approved intake capacity, twenty five percent of the seats are reserved for the students having domiciled in the State of Telangana.

Policy for Admissions of International Students

This document summarizes the approach of NICMAR University of Construction Studies, Hyderabad for the admissions of International Students only. NICMAR University of Construction Studies, Hyderabad reserves the right to modify any part of this document including the various criteria and cut-offs mentioned at any time till the actual admission process for the batch.

Objective:

The basic objective of NICMAR University of Construction Studies, Hyderabad admission process is to identify meritorious candidates for admission under seats for International Students. NICMAR University of Construction Studies, Hyderabad duly recognize academic merit consistency and experience.

Seats:

As per UGC guidelines dated 30th September 2022 (for admission and supernumerary seats of international students in undergraduate and postgraduate programmes in higher educational institutions in India), NICMAR University of Construction Studies, Hyderabad earmarks up to 25% supernumerary seats for international students, over and above of total sanctioned enrolment for Undergraduate and Postgraduate programmes.

The 25% of the supernumerary seats for international students will not include the international students under exchange programmes or/and through Memorandum of Understanding (MoU) between institutions or between Government of India and other countries.

The International Student is defined as the following:

Foreign National (FN): Foreign National shall mean citizens of all countries other than India, who are not of Indian origin as defined under the expression Person of Indian Origin (PIO)/ Overseas Citizen of India (OCI). An international candidate holding a foreign passport is eligible to apply as a Foreign National (FN).

NRI: An India citizen who is ordinarily residing outside India and holds Indian passport.

Person of Indian Origin (PIO): A person who or whose any ancestors was an Indian national and who is presently holding another country's citizenship/nationality i.e. he/she holding foreign passport.

Overseas Citizen of India (OCI): A person who is registered as Overseas Citizen of India (OCI) under section 7A of the Citizenship Act, 1995.

Eligibility Requirement:

Undergraduate Programmes:

Only Students, who have passed XII/ HSC/ O - Level (10+2) or equivalent are eligible to apply for admission. Students meeting the eligibility criteria as declared in the NICMAR University of Construction Studies, Hyderabad's programme brochure/website would be considered for admission.

Note:

Candidates who are likely to complete standard XII/ HSC/ A - Level or equivalent before commencement of programme can also apply, subject to meeting the eligibility criteria as declared in the NICMAR University of Construction Studies, Hyderabad's programme brochure. If selected, such candidates will be offered admission to the programme provisionally. At the time of commencement of the programme, such candidate must produce standard X/SSC (10th) and standard XII/ HSC (10+2) or equivalent examinations mark sheet along with school leaving certificate/migration certificate, failing which the candidate's provisional admission offer will stand cancelled.

A student is eligible to apply as a Non-Resident Indian (NRI) if he/she is an Indian National and has appeared for either 10th or 10+2 (equivalent to the Indian 10th or 12th) examination outside India. It is mandatory for one of the two qualifying examinations to be given outside India.

Postgraduate Programmes:

For any discipline, applicant must have completed 12 (10+2) years of formal education at the school level followed by a Bachelor's Degree of at least 3 years duration. Students meeting the eligibility criteria as declared in the NICMAR University of Construction Studies, Hyderabad's programme brochure/website would be considered for admission. In case any of the degree is obtained from the University/Institute/Board outside India, the candidate must produce the equivalence certificate by the Association of Indian Universities (AIU). In this regard, the rules framed by the Association of Indian Universities and the Ministry of Education will be applicable. In case of the degree is obtained in India, it must from any of the Universities incorporated by an act of the central or state legislature in India or other educational institutions established by an act of Parliament or declared to be deemed as a University under section 3 of UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of Education, Government of India.

Note:

Candidates appearing for the final year of the Bachelor's degree as well as those who have completed degree requirements and are awaiting results can also apply. If selected, such candidates will be allowed to join the programme only if they submit a certificate from the Principal/Registrar of their university/college/Institute at the time of joining. Such certificate should state that the candidate has completed all the requirements for obtaining a Bachelor's degree on the date of the issue of the certificate. The deadline for submitting the mark-sheet and the certificate would be within one month

from date of commencement of programme. Non-fulfillment of this condition will automatically result in the cancellation of the provisional admission.

A student is eligible to apply as a Non-Resident Indian (NRI) if he/she is an Indian National and has appeared for the 12th examination (equivalent to the Indian 12th) or graduation outside India. It is mandatory for one of the two qualifying examinations to be given outside India.

Fees Structure:

The fee for international students is as proposed in 'Fee Policy for International Students'.

Admission Process:

The admissions department follows a well-defined and detailed admission process. NICMAR University of Construction Studies, Hyderabad uses multiple parameters, namely academic performance in school, high school and graduation programmes as well as candidate's scores in SAT/ UG-NCAT and GMAT/GRE/PG-NCAT to judge the suitability of candidates for the undergraduate and post graduate programmes respectively. Relevant work experience, if any, is also given weightage. The admission process includes a personal interview, conducted through remote video conferencing for international students.

Students applying under the NRI category are NOT required to appear for the English Proficiency Test (IELTS Examination). Students applying as FN/PIO/OCI are required to appear for the English Proficiency Test (IELTS examination). However, students whose medium of instruction for their XII/HSC/A-Level or equivalent (for undergraduate programs) and undergraduate programs (for postgraduate programs) is English are not required to appear for the English Proficiency Test (IELTS Examination).

Two Letters of Recommendation are required to apply for any of NICMAR University of Construction Studies, Hyderabad programme. The Admission Process of NICMAR University of Construction Studies, Hyderabad consists of:

Online application form.

Regulatory Requirements:

Equivalence Certificate for Educational Qualifications / Degrees obtained outside India - If any of the Educational Qualifications/ Degrees (10th, 12th, or UG) are obtained from the University/Institute/ Board outside India, the candidate must produce the equivalence certificate by the Association of Indian Universities (AIU). The rules framed by the Association of Indian Universities (AIU) and the Ministry of Education will be applicable in this regard.

Documents: All Documents needs to be translated into English by authorized translators.

Entry VISA - On receipt of the provisional offer letter from NICMAR University of Construction Studies, Hyderabad, students should approach an Indian embassy/consulate and request a Student VISA with multiple entries (dual entry at the minimum for practical reasons) as per existing rules/provisions notified by Government of India regarding visa. On entering India, the student should register at NICMAR University of Construction Studies, Hyderabad and pay the program fees. NICMAR University of Construction Studies, Hyderabad will issue a bonafide certificate after registration as a Student.

Registration at the Foreigners Regional Registration Office: by Student - Within 14 days of entering India on a student visa and after receiving a bonafide certificate, the student should apply to the Foreigners Regional Registration Office (FRRO) for a Registration Certificate / Residential Permit (RC/RP). The application form and checklist may be downloaded from the FRRO website. All existing rules/provisions notified Foreign Regional Registration Offices (FRRO) must be followed by the students. The student should submit Medical Test Report within a week from the date of admission from a Registered Medical Practitioner OR a Medical Practitioner nominated by NICMAR University of Construction Studies, Hyderabad.

The student should have adequate Medical Insurance Cover.

Information to Local Administration: by NICMAR University of Construction Studies, Hyderabad - Upon the arrival of the student in the campus/hostel, the NICMAR University of Construction Studies, Hyderabad will inform/report to the local administration (Police Dept.) as per the law applicable in the State of Telangana.

Orientation/Sensitization towards culture, law, and customs of the Land - International Students, upon their arrival on the campus of NICMAR University of Construction Studies, Hyderabad, will be sensitized around the law of the land, local culture, and customs through a formal orientation session. Final Placement – Placement department will help the students in connecting and networking with the companies for career opportunities.

All existing rules/provisions notified by Government of India regarding visa/ Foreign Regional Registration Offices (FRRO) etc. and Government of Maharashtra must be followed by the students. Any dispute concerning admissions for the International Students would be subject to the jurisdiction of the competent courts within the territorial jurisdiction of city of Pune Only.



Rules and Regulations:

Final admission will be considered and granted only when student report with appropriate visa endorsed for NICMAR University of Construction Studies, Hyderabad i.e. for undergraduate and postgraduate student: Student Visa is required. Admissions will be considered only from the day student report with appropriate visa.

Provisional admission letter does not warrant admission to the said programme. On your arrival in India and NICMAR University of Construction Studies, Hyderabad, student need to submit and verify your original documents (including passport, student visa, academic documents) at NICMAR University of Construction Studies, Hyderabad for initiating the admission process.

International Student Cell:
